**Rules and Regulations**

1. Auditions shall be held as follows: May 3rd, 2pm —Trincity Mall, May 4th, 2pm—South, May 18th, 2pm—Harvard's Club, Port-of-Spain.
2. Auditions shall be open to everyone 25 years and under.
3. Three judges will adjudicate the auditions to select 10 participants from each zone. These participants will go on to the semi-finals where the top twelve will be chosen for the finals being held on June 10th, 2008 at the St. James Amphitheatre.
4. Each performance shall not be more than 5 minutes long.
5. All musical accompaniments shall be provided by the contestant on a compact disc. Finalists will be accompanied by a live band and will receive an appearance fee of \$300 and a certificate of participation.
6. The criteria for judging shall be—Material content- 30 pts, Performance- 30 pts, Presentation- 30 pts, Dress- 10pts.
7. The prizes for the finals will be disclosed at a later date.
8. Additional prizes of \$1,000 for the finals awarded for Best Dance, Best Drama, Best Vocalist and Best Instrumentalist.
9. This competition is for amateurs only. Persons deemed to be professionals by virtue of their reputation and past We Talent 1st place winners shall not be allowed to participate.
10. All competitors, by registering for this competition, agree to having their performance recorded for live broadcast on radio and/or television and for archival purposes.
11. The judges decision shall be final.
